- Be responsible for all cookies received and for submitting all money on time to the troop cookie manager.
- Sell cookies only during the scheduled program dates of December 24, 2009 – March 7, 2010.

I understand that:

- My daughter must be a registered Girl Scout to participate in the Cookie Program.
- Cookies cannot be returned.
- Before I sign a receipt for acceptance of any cookies, I will verify the quantity.
- Girls may use the internet to notify family and friends of the Cookie Program. Online transactions using eBay, Craigslist, or other auction sites are prohibited for girls and adults. This is for the girls' safety.
- I am financially responsible for all cookies and money collected. In the event that legal assistance becomes necessary to collect this money from me, I will pay collection fees, court costs and attorney fees, in addition to the total money owed.
